3. Pledge of Allegiance was led by Mayor Kendrick.
4. Consideration of Council to fill Unexpired Council Term **CONSIDERATION OF COUNCIL TO FILL UNEXPIRED TERM** – At their July 15 meeting, City Council made the decision to fill the remainder of Robert Rodriguez’s unexpired term by Appointment. After soliciting letters of interest from the community, eighteen (18) residents submitted letters of interest by the deadline of August 7, 2013. At their August 19 meeting, City Council made the decision to adjourn to a separate meeting to consider the candidates for appointment. Each candidate was given four (4) minutes to make a statement. The statements were made based on a random order determined by the City Clerk. City Council took into consideration the letters of interest and the statements of each candidate.  
  
After consideration of all candidates, Council agreed to select two names for further consideration.  
  
After presentation by candidates, the following nominations were made.  
  
Council Member Carder nominated Tim Hepburn and Norm Faustini  
Mayor Pro Tem Rosales nominated Tim Hepburn and Ron Ingels  
Council Member Redman Ron Ingels and Carrin Bouchard  
Mayor Don Kendrick nominated Ron Ingels and Gilbert Ivey

After discussion of the top two candidates, Tim Hepburn and Ron Ingels, the following nominations were made:

Council Member Carder nominated Tim Hepburn  
Mayor Pro Tem Rosales nominated Ron Ingels  
Council Member Redman nominated Ron Ingels  
Mayor Kendrick nominated Ron Ingels.

After further discussion, it was moved by Rosales, seconded by Redman, and unanimously carried to appoint Ron Ingels to fill the unexpired City Council term of Robert Rodriguez and adopt the following resolution.

**Resolution No. 13-80** – A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LA VERNE, COUNTY OF LOS ANGELES, STATE OF CALIFORNIA, MAKING AN APPOINTMENT TO THE UNEXPIRED CITY COUNCIL TERM OF ROBERT RODRIGUEZ. **Approved and Ron Ingels appointed.**

Ron Ingels was sworn in as a Council Member by the City Clerk.

This was the time set aside for anyone wishing to address the City Council on items not listed in any other place on the agenda. Mayor Kendrick called for public comment.


Joan Reyes, 3530 Damien Avenue, La Verne, requested that people who have yard sales be required to take down their signs and dispose properly.
